

Memorandum of international cooperation

29.11.18

date

State Higher Educational Institution "University of Educational Management" NAES of Ukraine (Ukraine), represented by the Rector Mykola Kyrychenko, acting under the Statute, on the one hand, and Moldova State University, represented by the Rector Gheorghe Ciocanu, acting under the Statute, on the other hand, further "Parties", concluded a memorandum on:

1. Subject and Purpose of the Memorandum

- 1.1. The Parties undertake to collaborate on educational development (second higher, distant, postgraduate pedagogical education): to conduct collaborative research and methods studies.
- 1.2. The main purpose of collaboration is further development of education, pedagogical and psychological sciences in Ukraine and the Republic of Moldova.

2. Obligations of the Parties

- 2.1. Regularly inform each other about the results of activities on development in education, pedagogical and psychological sciences (second higher, distant, postgraduate pedagogical education) in Ukraine and the Republic of Moldova.
- 2.2. Participate in organizing and conducting of joint activities (workshops, seminars, conferences, etc.) concerning development of education, particularly second higher, distant, postgraduate pedagogical education.
- 2.3. Introduce various forms of exchange of experience in education, pedagogical and psychological sciences.
- 2.4. Conduct an exchange of experts to study the educational systems of Ukraine and the Republic of Moldova, share experience and educate students.
- 2.5. Promote publication of scientific and methodological materials.
- 2.6. Conduct an exchange of scientific, scientific-methodical and educational-methodical literature.

3. Rights of the Parties

- 3.1. The Parties are independent in taking decisions, in choosing the means, forms and methods of activity. The Parties are governed by the legislation of their states and this Memorandum.
- 3.2. This Memorandum implies no financial obligations. The implementation of joint

programs, projects and activities generated from this Memorandum will take place on the basis of additional agreements, including those that determine the financial obligations of the Parties.

3.3. By mutual consent of the Parties, this Memorandum may be amended and supplemented in a separate document as a constituent part of this Memorandum.

3.4. This Memorandum shall enter into force on the date of signing and will be valid for five years. By mutual agreement of the Parties, its effect may be automatically renewed for successive periods of five years.

3.5. Each Party may terminate this Memorandum by written notice to other Party of its intention. In such a case, this Memorandum shall terminate one month after the notification.

3.6. In case of termination of this Memorandum, its provisions remain in effect till the full implementation of its joint programs and projects started within the duration of this Memorandum.




