GENERAL REQUIREMENTS

The text should be typed in text editor MS Word, the file must be saved in one of the formats: *.rtf, *.doc, *.docx.

Page Format – **A4**, font – **Times New Roman**, font size – **14**.

Settings size:

left – 30 mm; right – 15 mm; top – 20 mm; bottom – 20 mm; alignment – the width; interval – 1; paragraph – 1,25 cm.

ACCEPTABLE STANDARDS FOR THE RESEARCHER

The percentage threshold of the **text originality** in terms of the main research results presentation, as well as the review of sources, excluding standardized academic clichés and bibliography, according to the results of textual coincidences:

The level of plagiarism cannot exceed 5%;

Citation level – no more 25%;

Uniqueness - from 85%.

PUBLISHING DESIGN OF ARTICLE'S STRUCTURAL ELEMENTS

The paper submitted for publication should include:

- **1. UDC** (The Universal Decimal Classification).
- 2. Name and surname (expanded, align on the left edge, clarendon, 12 pt, interval 1).

ATTENTION! The author's surnames and names are indicated as they are indicated in the identity documents (for example, Anna or Hanna)!

Please note that in accordance with the editorial ethical requirements, the list of authors should indicate the persons who have made a significant contribution to the scientific research presented in the article. Academic status, position, or other seniority should not determine the order in the list; the order of authors should indicate the relative leadership and value of the researchers contribution to this scientific work.

3. Title of the article (14 pt, clarendon, uppercase letters, paragraph without indents of the first line, centre alignment).

ATTENTION! The title of the article can contain no more than 10 words, it should reveal the essence of the problem to the general public of scientists. Avoid abbreviations.

4. Abstract. The word "Abstract" (bold, 14 pt). Then in the same line – the text of the Abstract in the language of the text of the original article (if the article is in Ukrainian, the Abstract must be in Ukrainian, if the article is in English, the Abstract must be in English).

The purpose of the abstract is to draw readers' attention and get them interested in reading the whole article. Writing the abstract you should not use general phrases, as well as specify non-essential details and well-known statements. The methodology **description** is reasonable in case of its novelty or interest in terms of this work. The **advantages** in the abstract are given to new results and long-term data, important discoveries, that refute existing theories, as well as data that, in the opinion of the author, are of practical importance.

Avoid direct repeats of any piece of work. The **title** of the article should not be duplicated in the abstract text. Besides, you should avoid including tables, drawings, diagrams, and formulas, use the abbreviations and symbols except commonly used ones. If the abbreviations are introduced, then at first use it is necessary to give them a decoding.

The abstract should be at least 1800 characters with spaces.

Keywords (14 pt, bold). Next in the same line – keywords – from 5 to 10 terms, separated by the symbol ";" (The interval between the paragraphs "abstract" and "keywords" should be 12pt).

Note that *author data, title, keywords, and abstract* will be used as metadata for describing your article, so they should be as precise as possible to describe its content. To facilitate the search for this content on the Internet, please avoid overly generalized and complex wording, use only well-known abbreviations.

THE TOTAL NUMBER OF PAGES IN AN ARTICLE SHOULD BE NOT LESS THAN 0.5 PRINTED SHEETS

5. The text of the article should contain the following required elements:

This section analyzes works that initiate the solution of the identified problem and are based on the author. As a result of the analysis of sources, it is necessary to distinguish previously unresolved parts of the general problem, which is devoted to the article:

- * references to sources are given in square brackets, for example [10];
- ❖ pages are separated by a comma [3, c. 35]: 3th source, 35th page;
- in the case of quoting several sources at the same time, it is necessary to list each number separately, in their own brackets, through a comma or a dash:
- **❖** [3], [4], [5], [6] aбо [3] − [6].

AIM AND TASKS / META TA ЗАВДАННЯ

Purpose of the article: a brief description of the study.

The tasks include a synthesis of data aimed at formulating a hypothesis or concept, a particular model, developing and selecting methods, and the conditions for conducting a research.

THEORETICAL FRAMEWORK / ТЕОРЕТИЧНІ ОСНОВИ

This section presents concepts, approaches, principles, methods and other provisions on which the research is based directly. The main terms, concepts and categories, which are the basis of the research, are indicated.

RESEARCH METHODS / МЕТОДИ ДОСЛІДЖЕННЯ

In this section, can be described a methodology for preparing and conducting a research, experimental basis, participants in the research or the objects under study. The characteristics, criteria, indicators and parameters on which they were evaluated are also mentioned. Names and registration numbers of scientific programs, projects and research works, within which the research was carried out, may be given.

This section provides analysis and justification of scientific results. Recommended division into subsections and paragraphs.

Lists

Lists are executed as follows:

- numbered «1.», «1)», «a)», «VI.»;
- ❖ marked « », «•».

Formulas

Formulas and individual mathematical symbols and letters to indicate values in the text must be typed in the editor MS Equation, without framing and pouring. font – **Times New Roman**, **14 pt**, center alignment, numbering – in parentheses, on the right:

where cit – number of citations, r_0 – the largest index of the row j , such that $r_w(j) \le cit_j$

Pictures

Illustrations (pictures, drawings, schematics, graphs, maps, screenshots), tables should be submitted immediately after the text, where they are mentioned for the first time, or on the next page. All pictures should have a link in the text. Illustrations are indicated by a word «Fig.», numbered sequentially in Arabic numerals, aligned in the centre. The names of illustrations are placed after their numbers. Illustrations are supplemented with explanatory data (under a picture signature). The name of the picture is written with a capital letter and must be placed in the middle of the sheet under the illustration, italics. After the name the point is not put. The quality of the illustrations should ensure their accurate reproduction. All objects in simple picture that are executed in **Word**, must be grouped together. Illustrations in the article may be black and white or colored, have the same style, filed in one of the formats (**jpeg, bmp, tif, gif)** with resolution no less than **300** dpi., if **ONE PICTURE** appears in the test, it does not have a number.

It is necessary to leave one blank line before and after the picture.




Fig. 1 Harold Kerzner triangle

After the table it is necessary to leave one empty line. if **ONE TABLE** appears in the test, it does not have a number.

If there are no more than six authors (editors, if the author is absent) in the publication, then the link should specify them all through the comma; the surname of the author is preceded by a comma and the word «and» is indicated (see bibliographic description of books with 1-6 authors).

If more than six authors (editors, if the author is absent) is specified in the publication, then it is necessary to specify the first author and «etc.» (see bibliographic description of books with 7 and more authors).

Names of journals, conferences, organizations, publishing houses, scientific institutions should be indicated in abridged form. The list of abbreviations can be found at the link:
